1. 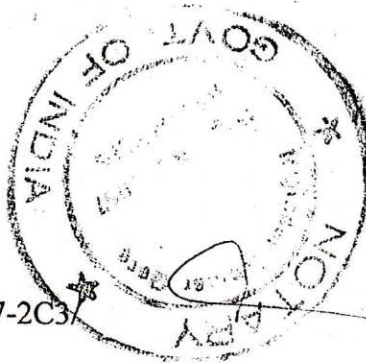
2. It is compulsory to teach Pbi upto 10th std in your school and board would make necessary arrangement for conducting Pbi exams in such schools. If it is not done N.O.C. can be cancelled with immediate effect.

3. The School management would promise to pay salary and other allowances to teaching and non-teaching staff in accordance with Govt. employees, after getting affiliation from C.B.S.E. New Delhi otherwise N.O.C. can be cancelled with immediate effect.
